### **Discussion**:

- Calendar

### VIII. NEW BUSINESS

a. SMDL OverDrive Agreement

<u>Motion</u>: Ms. Nigg moved to delegate authority to the SMDL OverDrive Coordinator to negotiate contracts with OverDrive and to set an annual budget for the collection on behalf of the group and delegate collection development authority to OverDrive.

#### **Discussion:**

- We give permission to the consortium to talk to OverDrive to make decisions for this collection of electronic materials, allowing OverDrive the permission to determine what is in the collection.
- Currently the staff is making these decisions but the library doesn't have the staff or the expertise.
- This will formalize the agreement.
- Costs \$2,000 on an annual basis, determined on population of the service area.
  - o 15% is hosting
  - o 85% is content
- Contract was negotiated as of 10/1/22 for a 3-year term

#### b. Replacement computers – public and staff

<u>Motion</u>: Ms. Shaffer moved approve the purchase of new computers to replace public and staff devices at a cost not to exceed \$3,500.
