b. Director raise -

Motion: Ms. Nigg moved to provide a 3% increase to the base wage of Director Hayes (\$40,808.60 annually, stipend amount \$2040.43, total \$42,849.03) Discussion: Members of the Personnel Committee shared their rationale with other Board members. Roll Call Vote / Result: Unanimous consent, motion passed. Director Hayes will provide the updated rates to the payroll company and request the payout of vacation and retroactive pay.
