THE MEETING WILL BE HELD ELECTRONICALLY.

The Library Board of the Galesburg-Charleston Memorial District Library will hold a special meeting Tuesday, June 9, 2020 at 5:00 p.m. This meeting will be held electronically pursuant to the Open Meetings Act and Governor Whitmer's Executive Order 2020-75. The purpose of this meeting is to discuss a Reopening Policy and Plan. Pursuant to Executive Order 2020-75, the Library Board gives notice of the following:

1. **Reason for Electronic Meeting.** The Library Board is meeting electronically because Executive Orders 2020-77 and 2020-69 require that the Library is closed to the public on the date of the meeting. Therefore, the public cannot be physical present and provide comment in the Library Building. The Board is holding its meetings by electronic means only because residents must remain at home or in their place of residence to the maximum extent feasible, and all in-person government activities have been suspended except for critical infrastructure workers and workers necessary to conduct minimum basic operations.

2. **Procedures.** The public may participate in the meeting electronically and may make public comment through either of the following methods.


